

# ADVANCE WITHDRAWAL OF VESTED BENEFITS TO ENCOURAGE HOME OWNERSHIP

This form is used to obtain the information necessary for all or part of the funds from a Rentes Genevoises vested benefits policy to be paid out in cash, in accordance with the Ordinance on the Promotion of Home Ownership using Occupational Pension Benefits (PHOO). Payments are made in Swiss francs only and by bank or post office transfer

- An early withdrawal can only be requested once every five years
- At the time of the early withdrawal, insured persons aged over 50 can receive either all the vested benefits acquired by the age of 50 or half of their total retirement assets, whichever is higher. This is only possible up to 3 years before the insured person reaches regular retirement age
- Withdrawals are subject to a flat-rate handling fee of CHF 500.-

- A copy of your valid official identity document bearing photo and legible signature and if you are married or in a civil partnership, that of your spouse or civil partner

- If you are single or divorced, please enclose a recent certificate of marital status (less than 1 month old)

This obligation also applies to persons who are separated, or in the process of divorcing or dissolving a civil partnership (SSPA). The signatory/signatories should come to the head office of Rentes Genevoises with a valid official identity document bearing a photo and legible signature. If a signatory is unable to attend in person, the signature must be certified by a notary or state official.
